**IMAGE USE AGREEMENT
PHOTOGRAPHED INDIVIDUAL AT LNS EVENT (MINOR)**

2. I hereby relinquish any right that I may have to examine or approve the Images or the use thereof in any manner whatsoever or printed material that may be used in conjunction therewith.
3. I will not, in any manner whatsoever, commence, maintain, pursue, continue or assign any action, cause of action, claim, suit, complaint or proceeding of any kind or nature whatsoever against LNS, its partners, employees, servants, agents, or any person, corporation, partnership or other legal entity that could seek contribution or indemnity from LNS, relating in any way to, or in any way connected with, the Images. I hereby agree that I will not bring or consent to others bringing claim or action against LNS on the grounds that anything contained in the Images, or in the advertising and publicity used in connection herewith, is defamatory, reflects adversely on me or violates any other right whatsoever, including without limitation, rights of privacy and publicity.
4. I hereby release LNS, its directors, officers, successors, assigns, representatives, consultants, employees, partners and agents from any liability that may occur as a result of said Images including, without limitation, any claims for invasion of privacy.
5. LNS shall not be obligated to use the Images or to use any of the rights granted hereunder, or to prepare, produce, exhibit, distribute or exploit the Images. LNS shall have the right to assign its rights hereunder, without my consent, in whole or in part, to any person, firm or corporation.
6. I have read the above prior to its execution and I fully understand the contents thereof; this agreement shall be binding upon me and my heirs, successors, legal representatives and assigns.
